DISTRICT, ELLIS COUNTY, TEXAS, ORDERING A GENERAL ELECTION TO BE ADMINISTERED BY
THE ELLIS COUNTY ELECTIONS ADMINISTRATOR ON NOVEMBER 8, 2022, FOR THE PURPOSE OF
ELECTING ONE (2) DIRECTOR AT-LARGE TO THE BOARD OF DIRECTORS OF BUENA VISTA-BETHEL
SPECIAL UTILITY DISTRICT TO HOLD OFFICE FOR A TERM OF THREE (3) YEARS; DESIGNATING THE
LOCATION OF POLLING PLACES; ORDERING NOTICE OF THE ELECTION TO BE GIVEN AS
PRESCRIBED BY LAW; DESIGNATING FILING DEADLINES; AUTHORIZING THE GENERAL MANAGER
OF THE DISRICT TO EXECUTE A JOINT ELECTION AGREEMENT AND CONTRACT FOR ELECTION

ORDER OF ELECTION

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF DIRECTORS OF BUENA VISTA-BETHEL SPECIAL UTILITY DISTRICT THAT:

- SECTION 1. A General Election is hereby ORDERED to be held on November 8, 2022, for the purpose of electing one (2) director at-large to the Board of Directors of Buena Vista-Bethel Special Utility District (the "District") and to hold said offices for a term of three (3) years (the "General Election").
- SECTION 2. The Elections Administrator of Ellis County, Texas, is hereby appointed the Early Voting Clerk for the General Election. The Early Voting Clerk shall supervise and conduct early voting by mail and in person for the General Election and shall provide additional personnel to serve as early voting clerks.
- SECTION 3. Applications for a place on the ballot may be delivered or mailed to the District at 312 S. Oak Branch Road, Waxahachie, Texas 75167. Delivery will only be accepted during the District's regular office hours 8:00 a.m. 5:00 p.m., Monday Friday. The deadline to file applications for a place on the ballot is Monday, August 22, 2022, at 5:00 p.m.
- SECTION 4. Early voting by personal appearance for the BVB SUD General Election shall be conducted according to the schedule approved by the Ellis County Commissioner's Court for the November 8, 2022 election.
- SECTION 5. All applications for an early voting mail ballot shall be received and processed by the Ellis County Elections Administration Office, 204 E. Jefferson St., Waxahachie, Texas 75165.

SECTION 6. The Secretary of the Board of Directors of the District is hereby authorized and directed to publish or post all notices prescribed by law in connection with the General Election ordered hereby.

SECTION 7. On behalf of the District, the General Manager is hereby authorized to execute a Joint Election Agreement and Contract for Election Services by and between the District and the Ellis County Elections Administrator for the General Election, a copy of which is attached hereto as Exhibit "A" and incorporated herein by reference for all purposes.

SECTION 8. The Ellis County Elections Administrator or qualified persons appointed by the Ellis County Elections Administrator or the President of the District shall serve as election judges.

SECTION 9. The Ellis County Elections Administrator is hereby appointed the custodian of voted ballots and shall retain all General Election materials of the District for a minimum period of twenty-two (22) months.

SECTION 10. The President and Secretary of the Board of Directors of the District, in consultation with the District's legal counsel, are hereby authorized and directed to take any and all actions necessary to comply with applicable provisions of the Texas Election Code and any other state or federal law in conducting the General Election whether or not expressly authorized herein.

SECTION 11. This Resolution and Order of Election shall take effect immediately upon its passage.
